

Rize Goal of the Month

Terms and Conditions

"Rize Goal of the Month" ("The Contest") is authorized by the Malaysian Football League and Emerce TV Sdn Bhd (collectively referred to as "The Organisers") and sponsored by Rize by Al Rajhi Banking & Investment Corporation (M) Bhd (RIZE)

RIZE Goal of the Month is a web-based engagement offered by Emerce TV Sdn Bhd, for Malaysian Football League (MFL), RIZE and based in Malaysia. By playing the game, you agree to be bound by the following Participation Rules and Terms of Service.

A) Participation Rules:

- To participate in Rize Goal of the Month, you must register for an MFL account with your email address or social media login information. Please ensure that you provide your valid mobile number during the MFL account creation. This is to ensure the mobile number corresponds with the mobile number registered on the Rize app, which will be required in order to qualify for the monthly prize.
- 2. Vote for your favourite goal scored as indicated in the Rize Goal of the Month video highlights on the MFL fan engagement platform.
- 3. To take part, you need to be at least 18 years old. Users are limited to only one account per mobile number.
- 4. To be eligible for the monthly fan-voting lucky draw, users must be a Rize account holder (Rizer) if they are not existing Rize's account holders. Please ensure that both your MFL account's mobile phone is the same as the mobile number that you've registered with your Rize's app.
- 5. Non-Rizers who have voted will not be eligible for the monthly fan-voting lucky draw.
- 6. In case of a dispute, the prize will be awarded to the authorised account holder of the email address, mobile number, or social media account.
- 7. All fan-voting lucky draw prizes are non-transferable and cannot be exchanged for cash or in kind.
- 8. A person is ineligible to participate if they are an employee or a director, or a member of the immediate family of an employee or director, of Malaysian



Football League, RIZE by Al Rajhi Banking & Investment Corporation (M) Bhd or Emerce TV Sdn Bhd.

B) Contest Rules:

- 1. The contest is valid from 18 April 2023 17 December 2023. The Organizers reserve the right to modify this period in the event where doing so is necessary for the proper facilitation of the Contest.
- 2. The prize will be awarded to the lucky draw winner. Only 1 Rizer will be picked from the pool of Rizers who have voted for Goal of the Month. Rizers who have won the prize ball are excluded from the future lucky draw throughout the contest period.
- 3. Organisers reserve the right to cancel, suspend, or modify the contest if necessary due to technical issues.

C) Monthly Prize:

The Monthly Prize to be given out to the Winner will be one (1) autographed official match ball by the team of the Winner's choice.

D) Notification of Winning:

- 1. Prospective winners will be contacted via email by Emerce within seven (7) days following the end of the contest round. In order to become a winner, he/she must answer the question posed in the email correctly.
- 2. You are responsible for keeping your email up-to-date.
- 3. In the event, for any reason whatsoever, the winner does not respond within a period of 14 days from the date of the notification email, the Winner shall be deemed as having forfeited the prize and the Organisers shall not be obligated to reimburse or compensate the Winner.
- 4. After the winners have been identified and a valid mailing address has been provided, the fulfilment of the autographed official match ball by the team of the Winner's choice will be done within 45 working days.
- 5. The Organisers reserve the right to exchange the autographed official match ball to any other items of similar value at any time.



E) Limitations of Liability:

 Contestants and Winners shall assume full liability and responsibility in case of any liability, mishap, injury, damage, claim or accidents (including death) resulting from their participation in the Contest, redemption and/or utilisation of the prizes and agree to release and hold the Organiser and its Prize partners free and harmless of any liability.

F) Data Protection

- By entering the Contest, you hereby agree that the Organizers may collect, store, disclose and process your personal data for the purpose of this Rize Goal of the Month Contest, receiving updates, news, promotional and marketing mails or materials.
- 2. By participating in Rize Goal of the Month, you hereby agree and give your consent to RIZE to collect, store, process and disclose your personal data in order to identify Rizers and to fulfil its obligations under Rize Goal of the Month Contest.
- 3. The Organizers and RIZE are committed to protecting the personal information of our participants and will take reasonable steps to ensure that participants' personal information is protected against unauthorized access, disclosure, or misuse. The Organizers will not sell or share participants' personal information with third parties without their consent.

G) General Terms & Conditions:

 The Organizers reserves the right to determine the duration of the Contest Period, and has the right to suspend, withdraw or terminate the Contest without assigning any reasons whatsoever by giving seven (7) calendar days' notice. Any cancellation, termination, suspension, or extension of the Contest shall not entitle the Contestants and Winners to any form of claim or compensation against the Organizers for any and all losses or damages suffered or incurred by the said Contestants and Winners directly or indirectly.
