

Rize Score Predictor – Liga Super

Terms and Conditions

"Rize Score Predictor – Liga Super" ("The Contest") is authorized by the Malaysian Football League and Emerce TV Sdn Bhd (collectively referred to as "The Organisers") and sponsored by Rize by Al Rajhi Banking & Investment Corporation (M) Bhd ("RIZE")

Rize Score Predictor – Liga Super is a web-based engagement offered by Emerce TV Sdn Bhd, for Malaysian Football League (MFL), RIZE and based in Malaysia. By playing the game, you agree to be bound by the following Participation Rules and Terms of Service.

A) Participation Rules:

- To participate in Rize Score Predictor Liga Super (LS) you must register for an MFL account with your email address or social media login information. Please ensure that you provide your valid mobile number during the MFL account creation. This is to ensure the mobile number corresponds with the mobile number registered on the Rize app, which will be required in order to qualify for the LS round/monthly prize.
- 2. Predict the results of MFL matches to earn points and compete against other users to win prizes which shall be granted per LS round/monthly.
- 3. To take part, you need to be at least 18 years old. Users are limited to only one account per mobile number.
- 4. To claim the prize money, the winners must be a Rize accountholder (Rizer) if they are not existing Rize's accountholders. Please ensure that both your MFL account's mobile phone is the same as the mobile number that you've registered with your Rize's app to get the prizes if you are the LS Round/monthly winner.
- 5. In case of a dispute, the prize will be awarded to the authorised account holder of the email address, mobile number, or social media account.
- 6. All prizes given are non-transferable and cannot be exchanged for cash or in kind.
- 7. A person is ineligible to participate if they are an employee or a director, or a member of the immediate family of an employee or director, of Malaysian



Football League, Al Rajhi Banking & Investment Corporation (M) Bhd or Emerce TV Sdn Bhd.

B) Contest Rules:

- 1. The contest is valid from 18 April 2023 17 December 2023. The Organizers reserve the right to modify this period in the event where doing so is necessary for the proper facilitation of the Contest.
- 2. Prizes will be awarded to the top 8 point scorers per LS round and top 3 monthly point scorers.
- 3. The prize money for the LS round/monthly prizes will be credited into the Winners' Rize account. Rize will not entertain any request to credit the prize money elsewhere.
- 4. You may predict the results of as many MFL matches as you want and can modify your predictions up until one minute prior to the match kickoff time.
- 5. Your ranking among all participants can be viewed in your MFL's account.
- 6. In the case of a tie, the participant who entered their selections first will win the tie breaker.
- 7. If a match is postponed, suspended, cancelled or removed, your predictions will be void.
- 8. Organisers reserve the right to cancel, suspend, or modify the contest if necessary due to technical issues.

C) LS Round and Monthly Prize:

The LS Round Prizes to be given out to the top 8 point scorers are detailed as below:

	Type of Prize
1 st Prize x 3 winners	RM100 each
2 nd Prize x 3 winners	RM70 each
3 rd Prize x 2 winners	RM30 each

The Monthly Prizes to be given out to the top 3 point scorers are detailed as below:

	Type of Prize
1 st Prize	RM800 and 1 MFL Club Jersey
2 nd Prize	RM500 and 1 MFL Club Jersey
3 rd Prize	RM300 and 1 MFL Club Jersey



D) Notification of Winning:

- 1. Winners will be contacted by Emerce via email within seven (7) days following the end of the contest round.
- 2. You are responsible for keeping your email up-to-date.
- 3. In the event, for any reason whatsoever, the winner does not respond within a period of 14 days from the date of the notification email, the Winner shall be deemed as having forfeited the relevant prizes and the Organisers shall not be obligated to reimburse or compensate the Winner.
- 4. It is also the responsibility of the Winner to download and activate their Rize account within a period of 14 days from the date of the notification email if they are not Rizers, in any event before the Winner claims his/her cash prize. If the Winner does not download and activate Rize account as previously mentioned, the Winner shall be deemed as having forfeited the prize and the Organisers shall not be obligated to reimburse or compensate the Winner.
- 5. Emerce will send the mobile phone numbers of the winners to RIZE to identify Rizers for the fulfilment of the LS round/monthly prizes.
- 6. After the winners have been identified and a valid mailing address has been provided, the fulfilment of the cash prize and MFL Club Jersey will be done within 30 working days.
- 7. The Organisers reserve the right to exchange the MFL Club Jersey to any other items of similar value at any time.

The Organizers and RIZE are committed to protecting the personal information of our participants and will take reasonable steps to ensure that participants' personal information is protected against unauthorized access, disclosure, or misuse. The Organizers will not sell or share participants' personal information with third parties without their consent.

H) General Terms & Conditions:

 The Organizers reserves the right to determine the duration of the Contest Period, and has the right to suspend, withdraw or terminate the Contest without assigning any reasons whatsoever by giving seven (7) calendar days' notice. Any cancellation, termination, suspension, or extension of the Contest shall not entitle the Contestants and Winners to any form of claim or compensation against the Organizers for any and all losses or damages suffered or incurred by the said Contestants and Winners directly or indirectly.
